6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14-06-2024 14:00 at the office of Belbari Municipality, Morang, Belbari, Morang, Belbari Municipality, Morang Province One, Nepal.

Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 47500, which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]).
