The bids will be opened in the presence of Bidders' representatives who choose to attend at **20-02-2022, 14:00** at the office of Belbari Municipality, Morang, Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of Nrs. **1,73,000** for contract no.**BM/MOR/W/NCB-05-078-79**, which shall be valid for 30 days beyond the validity period of the bid.
